YARD CLEAN UP

As we approach the season for yard clean up and raking leaves, remember the following for trash pick up:

- All lawn waste must be in brown bags placed next to cart or inside of cart.
- Each resident will be allowed 10 bags per month for the months of April, May, June, October, November and December. The maximum bags allowed per calendar year is sixty (60).
- For each household that exceeds sixty (60) bags of yard waste in a year, an overage tag will be required. Overage tags are \$2.00 per tag and can be obtained through the Department of Public Works.

TRASH TOTER REQUIREMENTS — For the month of September 2021, over 25 percent of properties had a trash toter violation! Per the Watson Farm Section I Plat Covenants and Restrictions, Section 14, the last sentence of the second paragraph reads "Garbage and trash cans shall be kept in approved containers which are not visible from the street, except on collection day." Enforcement has begun. Please remember, the board didn't make these covenants, and wants to be equal in enforcement in all of the covenants.
